1. WHAT ARE COOKIES? | COOKIES ON THIS SITE | CONSENT

Cookies are small text files that websites visited by users send to their devices, where they are stored and later sent back to the same websites on subsequent visits. Cookies are used for various purposes, have different characteristics, and may be used by the website owner or by third parties. 2. EXAMPLES OF SIMILAR TECHNOLOGIES

User online behavior tracking can also be performed using technologies similar to cookies. Below are some examples:

LocalStorage

This technology is used to optimize navigation without collecting data about the preferences expressed by the user (e.g., it stores a code that identifies the user's session after logging in, to prevent the user from having to re-enter their username and password on every profile page when accessing restricted areas).

Tracking Pixel

A "tracking code" or "monitoring code" is, in fact, a small piece of code released by some systems with the purpose of being implemented into others to track certain data related to the user and their browsing session or email opening, in a manner completely transparent to the user. The data tracked can vary, such as the day and time, geographical location, the type of device used for browsing, and, in more complex tracking pixels, the amount spent on a purchase order and other useful information for the marketing departments of the companies using them.

Plugins

A plugin is a program that interacts with another program to extend or enhance its original functionality. The most commonly used plugins are those from social networks, which allow, for example, the user to follow a page or social profile with one click, indicate that they like a web content with one click, and share it on their social network profile, etc.

Widgets

A widget is a graphical user interface component of a program, designed to facilitate user interaction with the program itself. The most commonly used widgets are those from social networks, which allow users to easily open social networks in a separate browser window.

These services allow interactions with social networks or other external platforms directly from the pages of a website. The interactions and any information acquired by the site are subject to the privacy settings of the third party that created these technologies.
